Guidelines for applicants:

- The application form must be completed in full and all details must be furnished accurately. The application form is available online at www.byomakusuma.org.
- Application should be submitted **no later than the date stipulated** on the application form
- A simple and transparent procedure using the above criteria will guide the selection process. If necessary, the Committee will conduct individual checks to ascertain further information about your proposed study, especially if you're a PhD candidate prior to making a decision. If necessary, the Committee may call for an online interview. The final selection will be made from among short listed candidates on the basis of a weighted index evaluation sheet by the selection team. Successful candidates will be informed by email.
- Decision to offer grant is subject to satisfactory information provided. Support may be full or partial depending on the requirement of the individual applicant and funding available.
- The initial funding will be provided for 12 months. The full length of funding provided will be no longer than 3-4 years, subject to receipt of an annual progress report. Candidates must submit their application form to request continuation of funding for remaining period no later than the date stipulated on the application form.
- Committee must be notified of any changes in the beneficiary's circumstances.
- Decision to continue funding will depend on the beneficiary's annual progress and any changes to circumstances.
- Students will be notified of the Committee's decision within 2 months from the date of application.
- The beneficiary is committed to offer 1 hour of voluntary service on a weekly basis to benefit other sentient beings. This may be in the form of facilitating a teaching session, conducting workshops, assisting with administrative and other tasks at the Byoma Kusuma Buddhadharma Sangha or other organisations during or after the completion of the course for at least one year.

Please note:

- ❖ Please note that the decision of the Committee to grant or refuse applications will be full and final. Completing and submitting an application form (online) is not considered as an approval of the grant. The Committee reserves the right to accept or reject applications based on the norms and guidelines of the SRREF.
- ❖ Documents once submitted will not be returned to the applicants and will be archived as confidential files with access only to the Committee of SRREF or administration of BKBDS. Therefore, the applicants are strongly advised not to send the originals of their credentials or documents unless they have been requested by the Committee. Students are advised to attest all copies of the original documents by relevant institution or organization prior to presenting their application form.

Addendum

The Committee will award a special need-based grant to individuals who wish to pursue training in secular fields, such as vocational training /apprenticeship in traditional Pauvva/Thanka art, Charya

Nritya and Charya Giti, and other artistic fields through private tuitions with authorised and qualified Pauvva artists, Charya Nritya Masters or institutions that offer specialist knowledge and training subject to the satisfaction of the committee.

Eligibility for special grant

- 1. Financial support is offered to Byoma Kusuma Sangha Members, Nepalese students from marginalised background and any interested student residing anywhere in the world.
- 2. Students have to complete an application form and submit to the selection Committee with all the necessary supporting documents, fulfilling the guidelines of SRREF.
- 3. Individuals who meet the selection criteria should:
 - Possess reasonable literacy and learning skills and provide evidence of admission with a qualified teacher or an accredited institution in Nepal
 - Candidate must be self- motivated and determined to complete their training/apprenticeship
 - Provide evidence of financial need
 - A written statement of intent in English or Nepali (not exceeding 700 words) to support their application, as well as highlight other information related to their personality/motivation/dedication in order to fulfil the SRREF guidelines. Individuals with adequate literacy skills may seek support to write their statement of intent
 - Individuals who have considerable voluntary experience, involvement in the charity sector, or service in Buddhist centres
 - Application must be supported with written evidence and one letter of recommendation
 - Scholarship allocation will observe a balanced approach. Female students are encouraged to apply
